This firm represents Senator Nicholas Scutari with regard to his candidacy for the Chairmanship of the Union County Democratic Committee, which election will take place on Wednesday, February 21, 2018 at 7:00 p.m. We are writing to bring to your attention a most serious matter which may have significant legal consequences relative to the currently certified membership of the Union County Democratic Committee.

Succinctly stated, we have been provided with what appears to be credible evidence that at least five "vacancies" in the UCDC from the Township of Union never in fact existed, although they were allegedly verified as such by the Municipal Chair and subsequently replaced by new members. Enclosed are Affidavits from the individuals involved verifying that they never in fact resigned, along with documentation alleging the existence of the vacancies and their replacements:

D-42 Ricardo & Versie McNeil
D-6 Rafael & Lucia Prisco
D-38 Tamesc Cohen
1325 Marcella Drive, Union, NJ
2261 Copper Hill Drive, Union, NJ
285 Indiana Street, Union, NJ

Since there were never in fact any vacancies, we believe the Committeepersons originally elected to the enumerated seats should be certified as lawfully seated and current Committee members.

The above facts, if accurate, raise a specter of conduct inconsistent with applicable law, and the integrity of the Committeeperson replacement process. As the individual charged with the certifying of Committee members, we are requesting your immediate review of the foregoing
