Dear Members of the Senate and General Assembly,

On behalf of the Better Choices for New Jersey Coalition and concerned leaders across the state, we write to express our strong concerns for the budget that passed last Thursday, which falls nearly \$1 billion short of being able to support core state investments and programs. Failure to reach a compromise only hurts our communities and families, and therefore we urge you to consider the compromise proposal of the Governor and move a budget with sustainable revenue streams.

We share a desire to ensure New Jersey not only meets its existing obligations but also has the ability to implement the public policy goals that will make New Jersey a national leader on so many issues. From public education to mass transit, and including social programs middle-class and working families rely upon, we need a budget that won't fall short.

The funding sources passed last week, unfortunately, are neither. They do not meet the needs of the state in FY 2019, falling upwards of \$1 billion short of what our state needs. Further, it is dependent on temporary sources, set to expire in either one or two years, or incomplete actions, failing to incorporate necessary funding streams such as the millionaire's tax or common sense measures, such as combined reporting. The bottom line, we will be unable to fix the damage done by Governor Christie's budgets over the past eight years.

We have worked together on many of these solutions in the past, and we now urge you to revisit the following and make them part of the Fiscal Year 2019 budget:

- Re-implement tax fairness by asking the very wealthiest to pay their fair share by adopting a tax on millionaires so we can invest in public education;
- Reinstate the sales tax to generate the long-term revenues we need to ensure stability of core programs;
- Implement "combined reporting" to close the loophole enjoyed only by large corporations, ensuring they can no longer park their profits and their Trump windfalls in other states to get around paying New Jersey taxes;

These are the tools New Jersey needs to protect our middle-class and working families for the long term. They will ensure our future prosperity is shared fairly by every New Jerseyan.

There are only three days left until the constitutional budget deadline. We ask you to encourage your leadership to work in good faith with Governor Murphy on a budget that will responsibly and fully invest in our shared future.
