Contributions to Menendez Victory Fund will be allocated as follows: The first \$2,700 of each contribution from a person and the first \$5,000 from a multicandidate committee will be allocated to Menendez for Senate and will be considered designated for the general election. The next \$10,000 from a person and the next \$5,000 from a multicandidate committee will be allocated to the New Jersey Democratic State Committee. The next \$5,000 of each contribution will be allocated to New Millennium PAC. Any contributor may designate his or her contribution for a particular participant. The allocation formula above may change if any contributor makes a contribution that, when allocated, would exceed the amount that the contributor may lawfully give to any participant.
