Mission of the Task Force

The NJ Latino Task Force is a volunteer driven collaborative made up of the leadership from each of the member organizations, HBA-NJ, NALEO Educational Fund and SHCCNJ, and is not affiliated with any specific campaign or political party. The mission of the NJ Latino Task Force is to advocate for Latino representation in the appointment process to ensure that Latinos are represented at all levels in state government.

Goals of the Task Force

- 1. Set up a process by which Latinos are ready to engage in the transition process for any future governor.
- 2. Meet with candidates for Governor prior to election to discuss our mission and goals and process for immediate engagement after election.
- 3. Develop a "Binder of Resumes" of qualified Latino professionals to submit to new administration for consideration to serve on Transition Team, Cabinet, Staff, Boards, Commissions and Authorities.
- 4. Introduce the Taskforce effort to the Legislative Leadership of NJ who play a critical role on the appointments process.
- 5. Develop ongoing dialog and meetings with the new Governor's administration and legislative leadership to advocate and be a resource for Latino appointments on an on-going basis and help identify qualified professionals for positions in government departments, boards, commissions and authorities throughout the new Governor's tenure.

Outcomes

After Governor Murphy's election, the Task Force worked successfully with the Governor and his leadership team to successfully engage Latinos in the transition process.

Key Election Observations:

- According to Exit Polls, 261,000 Latinos came out to vote (about 41% participation compared to 35.6% of General population).
- Of the Latinos who voted, about 214,000 voted for Phil Murphy.
- Latinos comprised about 18% of Governor Murphy's total vote count. (https://www.nbcnews.com/politics/2017-election/NJ)
- The total Latino population in NJ is 20%.
- Total percentage of Latino registered voters in NJ for 2017 was 12%

Key Observations of the Transition:

• Transition Committees Leadership

A Latino was selected to lead Governor Murphy's Transition Team

Out of the 82 names listed as co-chairs of Gov Murphy's Transition Team, twelve were Latinos. Ten of the names were from the list of resumes submitted by the Task Force. Overall, nine of the fourteen transition committees had Latinos represented. And of the two policy advisers announced, one was a Latino (director of transition policy committees).

- Transition Committees Membership (based on first initial announcement)
 Out of 500 overall people appointed to serve on Gov Murphy's Transition Team, 55
 were Latinos. Twenty-seven (27) were Latino males and twenty-eight (28) were
 Latina females.
- Latino representation in the Transition Team of Governor Murphy was 11%.

Other notable observations:

- Important policy Transition Team Committees needed more Latino participation.
 Those committees were: Education, Human & Children Services, Labor & Workforce
 Development, Military & Veteran Affairs, Stronger and Fairer Economy,
 Transportation & Infrastructure
- The Urban and Regional Growth and Stronger & Fairer Economy Committee needed

- more representation of Latino Mayors from urban communities.
- Representation of Latinos from South Jersey in the Transition Team leadership team was 7.3% (4 out of the 55); and total participation in the membership of Transition Team was a low percentage of 0.8 %.

Conclusions and Recommendations

Governor Murphy and his administration leadership have taken strong action to engage Latinos in his Transition Team, Cabinet and Administration. As the task of filling vacancies in state agencies, commissions, boards and authorities continues, the Task Force encourages ongoing dialog and meetings to continue to advance diversity in appointments of Latinos at all levels of NJ Government.

In order to continue in the progress already achieved, the Task Force makes the following recommendations to the Administration of Governor Murphy:

- Quarterly meetings between Governor's appointments representative and the Task Force leadership.
- Continue to work with Task Force leadership to identify qualified candidates for consideration for commissions, boards and authorities.
- Prioritize the appointment of Latinos to Top Tier boards and commissions in NJ
- Review all current openings and engage key partners to identify diverse candidates for all high-level staff appointments in key state agencies.
- Assign an office responsible for tracking the race and gender of employees and new appointments. This information is important to be able to track progress on diversity and inclusion in New Jersey.
- Mandate state agencies to track and report on their diversity efforts in contracting work to diverse consultants, contractors and vendors.
- Increase representation of Latinos from South Jersey to a number more representative of their population contributions' to the economy of New Jersey.

- OLS has access to "statutory required appointments" (by Senate President & Speaker)
- Taskforce will share blurb on appointments for Latino Caucus to include in their policy priorities to present Governor Murphy.
- Senator Pou will invite Task Force leadership to present at the next caucus meeting, likely date will be in March.
- Task Force shared relevant resumes with Senator Pour, broken into area of interest.

- The appointments office is conducting audit of boards & commissions to understand openings
- Scarlett will share openings with Task Force

- First, the administration has not completed the audit of all boards and commissions (B&C), but is prepared to make appointments when/where appropriate

- The Task Force will submit individual names, accompanying resume, and the board/commission of interest, based on the research done on openings.

Meeting with Senate President Steve Sweeney, Statehouse, Trenton, NJ (3/5/18):

- Senator's staff is conducting audit of boards & commissions to understand openings, once they have been identified, they will share with Taskforce
- Senate President Sweeney stated his commitment to work with Taskforce to identify Latinos for the Boards and Commissions he has authority over.
- For appointments coming from Governor's office, we will communicate with his office on our support for different appointments.
- Urge Taskforce to ID individuals who have relationships with respective Senators in their districts, as he always consults with them before moving forward a nomination.
- Reinstated commitment to work with Taskforce to improve diversity on all appointments.
