Commuting between New Jersey and New York City is never an easy task and almost every day we hear more and more complaints from frustrated commuters. However, yesterday's harrowing experience for commuters was the ultimate cry for help. When I saw the Port Authority's response to Thursday's snowstorm, I was shocked and mystified. It was complete chaos. How does an agency whose vital role to keep the region moving become paralyzed and completely shut down? Closing down the bus terminal, bridges, and tunnels was not only unacceptable, but caused paralysis throughout our local roadways as well. It revealed just how unprepared the Port Authority was to accommodate commuters during rush hour while encountering inclement weather.

As chair of the New Jersey Assembly Homeland Security and State Preparedness Committee, I find what occurred yesterday particularly disturbing. If the Port Authority's main goal is overseeing infrastructure in the region, certainly this was not the case last night and negligible at best. There was little to no communication or announcements posted on what actions commuters were expected to take and where to go. This left many New Jersey residents befuddled and stranded.

I, along with thousands of New Jersey residents, am outraged at the events that transpired yesterday. In demanding answers and insight as to how this happened, I am requesting a special hearing from the Port Authority for commuters to ensure that this never occurs again.
