VERIFIED PETITION**

Respondents

Petitioner, SERGIO SEGALINI, residing at 39 Jane Street in the Borough of East Rutherford, County of Bergen, in the State of New Jersey, Republican candidate for Mayor in the 2019 General Election, by way of this Petition, pursuant to statute, alleges and says:

1. At all times relevant herein, Petitioner was the Republican candidate for the office of Mayor of the Borough of East Rutherford.

2. At all times relevant herein, Respondent Bergen County Board of Elections maintained custody and control of the voting machines used in the General Election. The Secretary of Respondent Bergen County Board of Elections also serves as the Commissioner of Registration for Bergen County. Respondent Bergen County Board of Elections is the custodian of the vote by mail ballot applications, envelopes, vote by mail ballots, provisional ballots,

emergency ballots and other paraphernalia associated with respect thereto. Furthermore, Respondent, Bergen County Board of Elections is charged with the duty of counting all votes cast in the 2019 General Election for the office of Mayor of East Rutherford, certifying the results of the election, and conducting any recheck of the machines or recount of the vote by mail, provisional, military, and emergency ballots in accordance with the requirements of the General Election Laws at a time and place established by the Board of Elections.

3. At all relevant times herein, Respondent County Clerk of Bergen County has certain duties to perform in rechecking the machines in accordance with the requirements of N.J.S.A. § 19:28-1 et seq. and N.J.S.A. § 19:52-6 et seq. Respondent County Clerk serves as Clerk of the County Board of Elections, which certifies the result of any election including recounts.

4. At all times relevant herein, Respondent Municipal Clerk of East Rutherford served as election official for the General Election in the Borough. Respondent Municipal Clerk of East Rutherford also played a role in notifying the Bergen County Board of Elections of certain registration errors affecting voters in the Borough.

5. At all times relevant herein, Respondent Jeffrey Lahullier (“Lahullier”) was the other candidate for Mayor of East Rutherford.

6. A General Election was held for the office of East Rutherford Mayor on November 5, 2019 (“Election Day”).

7. The results were the General Election including all absentee and provisional votes was as follows:

Lahullier	854
Segalini	848

8. This included eighty-nine (89) absentee ballots and fourteen (14) provisional ballots for Lahullier and sixty-three (63) absentee ballots and fourteen (14) provisional ballots for Segalini.

9. Having reason to believe an error had been made in the counting of votes, Petitioner filed a Verified Petition seeking a recount of the paper ballots a recheck of the machines in the 2019 General Election.

10. Pursuant to court order, a recheck of the machines and a recount of the paper ballots was conducted on December 2, 2019.

11. The recheck of the machines resulted in no change.

12. However, the recount of the mail-in and provisional ballots resulted in a change.

13. As a result, Segalini's total increased by one (1) vote

14. Lahullier's total remained unchanged.

15. Certain absentee ballots remained excluded by the Board of Elections for various reasons and to date remained unopened.

16. The final tally certified by the Board of Elections was 854 votes for Lahullier and 849 votes for Segalini, a margin of five (5) votes. **See Exhibit A**

GROUND FOR CONTEST

17. East Rutherford Mayor is directly elected by the borough at-large for a four-year term in each year preceding the presidential election.

18. Upon information and belief, the following problems and violations of the provisions of N.J.S.A. § 19:29-1 and other provisions of Title 19, occurred that a fair, free and full expression of the intent of the voters was not had. To the extent known; voters are identified pursuant to N.J.S.A. § 19:29-2

A. Upon information and belief, the following non-residents of East Rutherford improperly cast ballots in the General Election on November 5, 2019 for East Rutherford Mayor. **See Schedule A**

B. Upon information and belief, the vote of Ico Cimera, 23 Shepard Terrace, was improperly discarded and should have been counted

19. Following the recount, the Board of Elections declared that Respondent Lahullier had received five (5) more voters than Petitioner Segalini.

20. Because the number of illegal voters and improperly discarded ballots exceeds the number of votes separating the candidates, these votes are sufficient to change the result of the election.

21. The election workers, through fraud, corruption or negligence, failed to follow and implement the statutory requirements and protections necessary to ensure a fair election.

22. As a result of these activities, and other activities, which a continuing investigation may disclose, the basic safeguards, protections and guarantees of a fair election and the full and free expression of the people were denied.

23. As a result of these acts and others, legal votes were rejected or illegal votes were counted sufficient in number to change the result of the election, cast a cloud on the election, or raise sufficient factual basis to declare the election void and invalid. This Court cannot determine the winner of the election with reasonable certainty, and must hold a contest to determine whether to declare a true winner or declare the election null, void, and invalid.

24. Petitioners hereby reserve the right to supplement, amend and plead additional claims as they arise and assert all rights under N.J.S.A. 19:29-5.

WHEREFORE, the Petitioner seeks relief as follows:

A. Issue an Order setting a suitable time and place for a hearing to review the objections set forth herein, to commence not less than 15 days and not more than thirty (30) days after the filing of this petition.

B. Permit the parties, prior to the date set for hearing in this matter, to review and examine all books, papers, tallies, ballots, applications, envelopes, envelope flaps, signature copy registers, voter books, voting authorizations, messenger books, rejected mail-in ballots, rejected provisional ballots and any other election materials, records, reports, receipts or any other documents or election paraphernalia which may be requested provided said examination occur on notice to all interested persons and in the presence of the appropriate official and representatives of Petitioners and/or Respondents.

C. Permit the parties, their agents, servants or employees, on five (5) days' notice, to take depositions of persons who participated in the election process, served as election officials, or who may otherwise be believed to have knowledge that would lead to relevant information with regard to the matter set forth herein in this petition, and grant the parties attorneys authority to issue subpoenas compelling the attendance and testimony of witnesses for depositions and trial.

D. Consider, at the hearing, the allegations of the legal votes rejected, the problems with the election process, and such other grounds as pleaded or may be presented at trial and issue a ruling on said allegations; declare, after the hearing, the Petitioners duly elected; or declare that it cannot be determined with reasonable certainty, who received a plurality of the votes cast for the office of Mayor of East Rutherford.

E. Enter an Order annulling Respondent's certificate of election pursuant to N.J.S.A.

§ 19:29-9. In the event that Respondents have been sworn into office, remove Respondents from office and enter an order pursuant to N.J.S.A. § 19:3- 25, declaring the office vacant pending the holding of a special election for the office of Mayor of East Rutherford.

F. Set aside the results of the election for East Rutherford Mayor, declare a vacancy in the office of East Rutherford Mayor pursuant to N.J.S.A. § 19:3-25, and if tied, order a special election be held in accordance with N.J.S.A. § 40A:16-16.

G. Award Petitioners damages, counsel fees and costs for this application;

H. Grant such other relief as may be just and equitable.

DESIGNATION OF TRIAL COUNSEL

Pursuant to R. 4:5-10, Leonard E. Seaman, Esq., is hereby designated as trial counsel for Petitioners.




