## Statements in Support of Sentencing Reform Legislation

"At a moment of national recognition of systemic racism in our criminal justice system, the New Jersey legislature has an historic opportunity to address severe disparities within New Jersey's criminal code. The Criminal Sentencing and Disposition Commission has laid out a reasoned and long overdue path to address these disparities. "We have come to understand that the more time someone spends in prison is not necessarily good for society; indeed, it is harmful to rehabilitation. Providing judicial discretion, allowing the sentencing judge to make informed decisions based on personal profiles – age, work history and a rehabilitation plan -- is far more effective than cookie-cutter sentencing.

"Due to certain sentencing laws in effect today, persons have automatically been incarcerated for decades upon decades. These laws have disproportionately impacted poor communities of color.
