"Since we see that every city-state is a sort of community and that every community is established for the sake of some good (for everyone does everything for the sake of what they believe to be good), it is clear that every community aims at some good, and the community which has the most authority of all and includes all the others aims highest, that is, at the good with the most authority. This is what is called the city-state or political community."



Some – in fact, many – do imagine it, and with some degree of courage and eloquence in the midst of the muck that is our public life at present. They are those seeking a finer and more civilized expression of our common union and common humanity.

Here's to them, in the words of our own favorite Jersey Boss:



RONALD L. RICE STATE SENATOR, LD-28



In a virtual world where the unreal is a substitute for the real, Rice may be the most misunderstood of public servants. He is real. Moreover, in a New Jersey public space given over to private gain, Rice actually dares to be real on a key front: public service, and policy knowledge for the purpose of the public good. The Newark-based Senator built a career out of taking tough – and detail-oriented – stands on the issues impacting his constituents, and during the debate over marijuana legalization, staked out a strong position in favor of decriminalization as an alternative to legalization.

His views put him in opposition with Governor Phil Murphy and Senator Nick Scutari, who would go on to become senate president.

Why?




"It's not about social justice, it's about money," Rice told InsiderNJ in 2019 in his Newark West Ward office at the intersection of South Orange and Sanford avenues.

"This new generation of black elected officials is not paying attention," he said. "They're not paying attention to the fact that black and brown people are being played. We have a greater responsibility. Why? Because we're the folks who were promised 40 acres and a mule, which we still never got, see? We're the group that's underrepresented in politics when white folk – political power – people are in control. There's an injustice taking place. The number of black folk in jail is three times greater than white folks. We've been trying to fix it. We think it's a social justice question. The guys in jail on marijuana possession convictions say, if it's about social justice, then turn me loose. And [then-Senate President Steve] Sweeney and the Governor are saying, "Well, I can't do that. You have to legalize recreational marijuana so my people can make a lot of money off of you.' Look, that's what's going on, okay? We should shut this state down because it's the most racist-intended thing since Jim Crow and some black leaders and clergy – under the auspices of social justice – are buying into that."

Rice wanted the legislature to move a social justice bill, which would free convicts incarcerated on nonviolent marijuana possession. "That would tell me you really are mature about social justice," said Rice. "Then you can have your debate on recreation once you pass social justice. They play one off the other, these guys. Why? They know the majority of my colleagues are never going to vote for recreational marijuana - they don't want to vote recreation - without the social justice tease. They're holding us hostage; hostage to the anticipated revenues from drugs."

Rice sought separate social justice and decriminalization bills ultimately securing some of what he wanted in Murphy's legalization sign-off, but not enough and not with the legal teeth he hoped to secure. The full realization of expungement remains an elusive legal point, which only Rice went statewide on in a sustained and impassioned way, with the precision of one who long ago gathered evidence in his work as a detective with the Newark Police Department.

MATT PLATKIN

ACTING ATTORNEY GENERAL FOR THE STATE OF NEW JERSEY



The Stanford-educated Platkin started his policy career at the Brookings Institution in Washington D.C., advising members of Congress on job growth and economic recovery following the 2008 financial crisis. In 2018, he became Chief Counsel to Governor Phil Murphy, where he oversaw an office of over 20 attorneys that advised the Governor on all legal matters, including legislation, executive orders, and administrative regulations. Platkin also was responsible for coordinating with the Attorney General's Office on civil matters, including affirmative litigations, and oversaw judicial and prosecutorial nominations. As a counterweight to U.S. Supreme Court rulings, he serves as a fierce guard dog of his boss' agenda, forming the Reproductive Rights Strike Force, to protect access to abortion care; and joining a national effort to regulate ghost guns.





DIANA HOUENOU CHAIR, NEW JERSEY CANNABIS REGULATORY COMMISSION

At a critical time, the fluent French speaker chairs the New Jersey Cannabis Regulatory Commission. Appointed by Governor Murphy, Houenou works with other members of the commission to regulate legalized cannabis. A former senior policy advisor and associate counsel for Murphy, Houenou advised the governor on policy and legislative issues concerning criminal justice, military and veterans, community affairs, and immigrants' rights.



JUDITH PERSICHILLI **COMMISSIONER OF THE NJ DEPARTMENT OF HEALTH**

Murphy came to his job of governor with money, but without any real government experience, which at the height of the COVID-19 crisis in particular made his reliance on Persichilli - a nurse by trade with years in the trenches as a healthcare executive - crucial.

Zalkind stands at the forefront of key policy advances in child welfare, early care and education and health care in New Jersey.


