

hats to storm a citadel of democracy (or they stuff the pockets of a sitting U.S. Senator like Bob Menendez with gold bars), although Hemingway might have actually meant to say Mussolini.

## THE PRESIDENTIAL CONTEST



New Jersey will serve as a critical staging area for the nation's contest, as President Joe Biden will emphasize federal infrastructure spending, including money for the Gateway (access to the region's core) Tunnel long denied by the GOP, while former President Donald J. Trump unwinds - or rages - on his private golf course in Bedminster.

Both candidates projected to win their parties' nominations have public perception problems.

One has a son in legal trouble.

The other faces four indictments totaling 91 felony charges.

According to a PBS News Hour / NPR Marist Poll in mid December 2023, 14 percent of voters say they dislike both Biden and Trump, more than four times the number dissatisfied with the two politicians last Election Day.

"Biden has a slight lead over Trump, his predecessor and current frontrunner for the Republican nomination, with 49 percent of registered voters saying they'd choose the incumbent and 47 percent siding with Trump, according to the latest poll. Independents favor Trump by an 8-point margin. The race remains virtually unchanged from August and is inside the poll's margin of error."

This from a Monmouth University Poll in December, 2023:

"Public opinion of Biden's overall job performance currently stands at 34% approve and 61% disapprove - his lowest rating in Monmouth's polling since he took office. Since September, his approval number has dropped four points and his disapproval number has increased by 6 points. Between October 2022 and July 2023, Biden's approval rating ranged between 40% and 44% while his disapproval number registered between 48% and 53%. Presidential approval has dropped among both Democrats (74%, down from 80% in September and 88% in July) and independents (24%, down from 30% in September and 38% in July); and it currently stands at just 5% among Republicans."

Trump's numbers from an Economist Poll in January: 46% favorable, 53% unfavorable.

Statistically even.

Even with Menendez spiraling into the morass and rank and file operators irritated by the Murphys' sense of entitlement, the New Jersey Democratic establishment under the leadership of Chairman LeRoy Jones trusts Trump will galvanize Garden State voters against him and create opportunities for gains, especially in CD-7.

But they also want to play a vital role in neighboring battleground Pennsylvania, which Biden narrowly won in 2020 50-49%, and where 2024 polls show a very close contest.

The latest from Susquehanna (Jan.

15-21) – 47% Biden, 39% Trump.

Quinnipiac (Jan/ 4-8) – 41% Biden, 39% Trump.

Redfield and Wilton Strategies (Dec. 28-30) – Trump 40%, Biden 39%.

Moreover, an Emerson College Polling survey of Pennsylvania voters "finds former President Trump leading President Biden 45% to 36%, while 11% plan to vote for someone else and 8% are undecided. In a potential 2024 U.S. Senate Election, incumbent Democratic Senator Bob Casey holds an eight-point advantage over Republican challenger David McCormick, leading 41% to 33%. Eight percent indicate they support someone else, and 18% are undecided."

It's volatile, with the country hanging in the balance just over the Jersey – not the Mexican –border.

Look for considerable fundraising by the Dems to the immediate westward.

As for the GOP, U.S. Rep. Jeff Van Drew (R-2) of South Jersey helms the Trump Campaign for the Garden State for, as he says, "Normal people like us."

## THE DEVELOPING U.S. SENATE CONTEST



Looking to give its full, potent support to the reelection campaign of President Joe Biden, and to provide a national level Latino presence - valuable in a battleground like Florida - New Jersey promptly self-combusted as U.S. Senator Bob Menendez (D-NJ) imploded.

You've read about the scandal.

So it would be Murphy (with the state's power centers behind her) versus Kim, he with the perfectly pure progressive credentials, unblemished by nepotism and upheld by rank and file Democrats

still reeling from the Murphys' audaciousness.



No one among the insiders gave Kim much of a shot, especially in a presidential election year. Yes, Lisa McCormick in 2018 put up a respectable 38-62% offthe-line showing (without campaigning and with no money) against a courtroom-bruised but still in-the-game Menendez. Why couldn't Kim stun the early stumbling Tammy Murphy campaign with a progressive good guy and good gal army on Election Day? Look, maybe it's doable, but the cravenness of the establishment to put Murphy up to begin with arises out of the extraordinary confidence they have behind the insulation of the party line.

Progressive activist Patricia Campos Medina and People's Organization for Progress Founder Larry Hamm also want the seat,

and will likely give Kim some fits from the left, enough to create some fracture and mild havoc, and perhaps afford Tammy Murphy at least one shot in a season of hell to assume a reproachful establishment gaze.

But the Democrats aren't the only ones running.

Serrano Glassner paid particular attention to Bashaw's entry into the contest, welcoming him to the GOP Primary with the dreaded tag of liberal.

"Curtis Bashaw is a liberal whom the voters cannot trust. He has personally donated over \$30,000 to Democrat politicians - including over \$15,000 to help the Democrat machine retain its grip on New Jersey government - and even worked against Donald Trump in his 2016 campaign against Hillary Clinton. Bashaw will never be a conservative champion and can't possibly understand the struggles of the working men and women of New Jersey. He is more in line with Gold Bar Bob and the Murphy Monarchy than he is the small businesspeople and blue-collar workers across New Jersey who are struggling under this disastrous Biden-Menendez-Murphy economy."



Sitting U.S. Rep. Andy Kim (D-3) wants to go to the United States Senate or go out on his shield as a quixotic political adventurer. Either way, he won't have to listen to Matt Gaetz anymore, Marjorie Taylor Greene, or Lauren Boebert. Might as well take a crack at a Senate seat if it forever relieves the deadening delirium of that trio's proximity.

Among Democrats, Assemblyman Herb Conaway (D-7), Assemblywoman Carol Murphy, and attorney Joe Cohn want to grab New Jersey's 3rd Congres-

and in the New Jersey Legislature has been the honor of my life," Conaway said in response. "I am ready to take that same work ethic and commitment to Congress. New Jersey families across the 3rd Congressional District deserve leadership that will fight back against the extremism and chaos in Washington."

Not so fast.

Murphy wants a fight.



## CONGRESSIONAL BATTLEGROUND



Having decided that the media represents a risk better left untaken, incumbent U.S. Rep. Tom Kean, Jr. (R-7) likewise appears little enamored of history and continues to determinedly slog through an oblivion of his own making.


chortled in late December of last year.

According to reports, Donald Trump's rhetoric is taken directly from Adolf Hitler's Mein Kampf - yet Kean Jr. has refused to condemn the wannabe dictator.

#### Why?

Because no matter how hard Kean Jr. attempts to act like a moderate, he will always remain loyal to Donald Trump, even when he's espousing theories from Mein Kampf.

Spokesperson DCCC Aidan Johnson: "Tom Kean Jr.'s silence on Donald Trump's decision to weaponize language from Adolf Hitler is telling: regardless of what the former president says or does,

She will be a credible general election candidate if she gets by Jason Blazakis, a former national security official. "Whether it's denying free and fair elections, taking away a woman's right to choose, or making New Jersey more expensive to live in, the MAGA extremist agenda isn't the Jersey agenda," says Blazakis. "Tom Kean is a rubber stamp for MAGA extremism. On reproductive rights, on the cost of living, and on protecting democracy, Kean gives in to extremists and Jersey pays the price."

Altman agrees, taking yet anoth-



er opportunity to beat up Kean, for example, after his vote for Mike Johnson as Speaker of the House. "As if his vote for Jim Jordan weren't shameful enough, Tom Kean Jr. just helped elect a bigot who wants to ban same-sex marriage as the Speaker of the House. Once again, he's shown his moderate rhetoric is nothing but an act, and that he is willing to throw the LGBTQ community under the bus and risk the rights they have won in order to further his political career and consolidate power in Washington D.C. Tom Kean Jr. owes it to his constituents to stop hiding and explain this indefensible vote."

Of course, that won't happen, but Altman appears committed to making Kean pay for his complacency.

## PASSAIC COUNTY'S FUTURE



This is a sad story.

One of the most shocking incidents in New Jersey politics in the last 20 years occurred on January 23rd, when Passaic County Sheriff Richard Berdnik walked into the men's room in Toro's Restaurant in his hometown of Clifton and, according to authorities, put a gun to his head and pulled the trigger.

The loss of a human being under any circumstances throws us into correspondence with the unknown or the ultimate, and in Sheriff Berdnik's case we must assume an additional weight of sorrow to know that he suffered - so much so that he took his own life. A reporter remembers the first time he saw Richard Berdnik.

Not long before, sitting Passaic County Sheriff Jerry Speziale announced that he had accepted a position at the Port Authority of New York and New Jersey and would not pursue reelection as a Democrat. This was 2010. His announcement threw the Democratic Party establishment into chaos a year after Gov. Chris Christie's position atop the ticket in Passaic helped the GOP rack

countywide wins. Then, on a deal arranged by Christie allies, Speziale would not man the party battlements, leaving Chairman John Currie and his allies speechlessly apoplectic.

Currie's first thought was to look to sitting state Senator John Girgenti (D-35) to run in place of the evacuated Speziale.

But Girgenti blinked, and others started lining up on the chairman's invitation to a screening at party headquarters, among them Paterson Councilman Aslon Goow and former Paterson Police

Chief Lawrence Spagnola.

Then Berdnik pulled up, got out of his car, and slung a jacket over his shoulder.

You knew.

You just knew.

This was going to be the pick.

How did you know?

Currie and U.S. Rep. Bill Pascrell (D-9) had already signaled their interest in the Clifton detective and longtime Police Department veteran and came away favorably impressed.

Berdnik that evening showed a sense of tranquility.

That was the word.

Tremendous tranquility.

He walked in and screened.

The Democratic Party gave him the line.

They had to, for who in the middle of a tempest can afford to resist a person whose professional excellence immediately imposed a transcendent calm?

That was Richard Berdnik.

He would go on, with Pascrell campaigning beside him, to defeat a credible Republican campaign for sheriff mounted by county jailer Felix Garcia.

Years later, he would, authorities said, shoot himself to death, and one wonders, amid the roil of eviscerating politics in our emotionally stratified and intolerant time, how much the world he entered, the world of public consumption for private gain, contributed to his demise.

He appeared often uncomfortable in the swim of events, an almost forlorn figure in a uniform, like a dignified constable in a circus.

We are unlikely perhaps to ever know why this man apparently committed suicide, on the heels of a public event, and we will, faced with anyone's ending thus, heed the words of the Japanese author Yoshikawa, who wrote, "Who knows the heart of the sea 100 feet down? Who knows its depth?" But whatever the case may have been, the mournfulness intensifies with the thought that one who so ably stepped up when needed, with an obvious sense of purpose and direction, a man who could inspire others, finally felt that there was nowhere else to go.

How does that happen?

We should know.





### IN MEMORIAM



#### OFFICER SICKNICK

President Joe Biden on Jan. 6, 2023, honored the memory and service of New Jersey's own, Officer Brian Sicknick, with a Presidential Citizens Metal presented to Officer Sicknick's parents.

Gladys and Charles Sicknick accepted the award from the President in a ceremony at the White House on the two-year anniversary of the Jan. 6th 2021 mob insurrection at the United States Capitol where Mr. Sicknick lost his life defending the democratic process. The youngest of three sons, Mr.

Sicknick grew up in South River and attended East Brunswick Technical High School. Prior to becoming a Capitol Police Office, he served in the New Jersey Air National Guard and was honorably discharged as a staff sergeant after serving in Operation Southern Watch and Operation Enduring Freedom.


On Jan. 6th, 2021, Mr. Sicknick was part of a "police line guarding the perimeter of the U.S. Capitol on the day that pro-Trump mobs attempted to stop lawmakers from

certifying President Biden's Electoral College victory.

"Sicknick was attacked with chemical spray during the confrontation and collapsed later that evening. He suffered from two strokes and died the next day. Sicknick was 42."

The New Jersey native is interred at Arlington National Cemetery.

The Sicknicks joined more than a dozen other individuals, among them other law enforcement offi-

proud advocates for educators, students, and the nation's **BEST** public schools.

cers who were injured on the fateful day, including a Capitol Police officer who died the day after rioters stormed the building, officers who died by suicide after defending the Capitol, and election workers who rejected efforts by former President Donald Trump to overturn the results of the 2020 election.

As he honored the officer's memory, President Biden spoke to the group at large about those law enforcement officers who died as a consequence of the mob. "This is warranted and overdue, particularly for the families of a hero defending our Capitol and our democra-

cy," said Biden. "People will look at you and say, that's the grace and dignity I want to display."

Gladys and Charles Sicknick have expressed their disgust with GOP leaders who went out of their way to buttress the false election claims by Trump and his supporters, or who failed to seek justice in the aftermath of their son's death.

"We got together and said we're not going to shake their hands," [said] Gladys Sicknick, mother of the late officer.

"She called out congressional Republicans who continue to support former President Trump, ʻgo down to Mar-a-Lago and you know, kiss his ring or whatever the hell they do down there, you know.' She met with Republican lawmakers last year asking for them to vote in support of creating a bipartisan, independent commission to investigate the Capitol attack. McConnell and McCarthy were opposed to the commission. The legislation passed the House, but it was blocked in the Senate due to a Republican opposition led by McConnell."
